## RESULTS OF THE GENERAL MEETING OF THE COMPANY HELD WEDNESDAY 12 JUNE 2013, AT 38 STATION STREET, SUBIACO WA

Yowie Group Ltd ("Yowie" or the "Company") advises that all resolutions put to the General Meeting of shareholders held today were passed on a show of hands which was also reflected in the proxy voting received.

Resolution 2 "Appointment of BDO (Audit) WA as Auditor" was a special resolution and passed with the requisite 75% majority.

## Incentive options

The Company wishes to advise that incentive options, the subject of resolutions 4 - 7, were to be priced at a percentage above 5 day VWAP ending on shareholder eligibility date, which was 10 June 2013. Five day VWAP for this period was 17.3 cents per share and on this basis the exercise price of the options will be as follows;
